- We have been serving the Christian community with quality educational services since 1979.
- We are a Washington State approved Private School and our staff holds current Washington certification. CCS is also a member of the Association of Christian Schools International and the Washington Federation of Independent Schools.
- We are governed by a school board consisting of parents and other significantly interested patrons. CCS is an independent, inter-denominational school.
- Our mission is to promote a Christ-centered, Biblically-directed educational environment that instills in each student excellence in education, moral character, and service to others.
- Our curriculum publishers include ABEKA, Bob Jones, Saxon, SRA and others and is a balance of academic and hands-on experiences.

Parent/School Covenants

CCS would like to thank you for joining us in the partnership of the academic, spiritual, and emotional education of your child(ren). We believe that parents are the primary educators (Deut. 4:9) of our children. However, to enable our school to function effectively and smoothly, we depend upon your support, which we view as essential. You are encouraged to discuss any of the following details with the staff.

AS PARENT/GUARDIAN...

1. We agree to support CCS with our prayers and positive attitude.
2. We have read the CCS Family Handbook and will abide by the guidelines.
3. We understand that the primary purpose of Christian education is to prepare our children to function effectively and joyfully in the world as servants of Jesus Christ. We accept that CCS is committed to a thoroughly Christ-centered and Biblically integrated curriculum. We understand that any verbalized philosophy, personal conviction, or theology which contradicts or conflicts with the Bible will not be tolerated in any school setting
(II Tim. 3:16; II Peter 1:21).
4. We give our child(ren) our permission to be involved in all school activities, including school-sponsored trips away from school, and we absolve CCS and administration from liability to us or our child(ren) because of injury occurring at school or at a school function. We understand that CCS carries liability insurance on every student covering activities on and away from campus; CCS carries liability insurance during the transporting of students on field trips when students are transported by bus. There is no liability coverage provided in such cases where parents, guardians or other individual drivers are transporting students on field trips. If individual drivers are transporting students, liability coverage must be the responsibility of the individual owners of the vehicles involved, and information on current insurance coverage must be provided to the school office.
5. In case of emergency, we give CCS our permission to obtain appropriate medical care for our child(ren) unless specific previous arrangements have been made.
6. We recognize that our participation in volunteer parent activities is essential to the success of the school. We agree willingly to serve required SALT hours. We also agree to make a sincere effort to attend Parent-Teacher conferences which are an effective means of staying informed and communicating.
7. We agree to uphold the academic goals of CCS within the family setting and assist with completion and accountability of homework as required for our individual child(ren). We recognize the need for sustained open communication with our child(ren)'s teacher(s).
8. We agree to have our child exposed to instruction in the Bible according to the CCS Bible curriculum and CCS Statement of Faith. I have read the Statement of Faith and subscribe to it without reservation.
9. We pledge to refrain from idle words of complaint or dissension. Rather, we agree to attempt to swiftly and scripturally settle grievances according to the Matthew 18 principles of discretion, mercy, and forgiveness in love (Matt. 18; Eph. 4:29-32). If conflicts arise I will follow these principals. I will;
 - Pray and examine my own heart before talking to anyone.
 - Talk directly to the teacher, administrator, or parent.
 - Keep any circle of involvement small and not gossip about a student or other parent or teacher via 'the grapevine'.
 - Attempt to resolve differences in a loving way.
 - Remember...right time...right place...right spirit.
10. We choose to support all CCS policies. CCS respects your right to disagree with a policy and there are ways to properly have a policy reviewed and changed if needed. There may be isolated incidents where I disagree but chose to support the school policy.
11. We understand that tuition payments are due on the first day of every month according to the tuition payment plan we have chosen. We agree to be timely in our financial obligation to CCS and to notify the school should any situation arise which makes this commitment difficult to uphold. Should our account become past due by 90 days, we agree to clear our account within ten days or withdraw our child(ren) unless a mutually agreeable arrangement can be made.

12. We agree that CCS has authority to discipline our child(ren) when necessary at school according to the CCS discipline philosophy and policy. We agree to communicate to our child(ren) the need to respect school authority and comply willingly with school classroom rules.
- We understand that CCS will not tolerate abuse of school property, disrespect to staff, or profanity in any form.
 - We agree to work with our child(ren), teachers, and aides on minor problems as they occur, particularly with home follow-up.
 - We acknowledge that correction or suspension may be deemed necessary by CCS. If such action is necessary, we will be notified by the school.
13. I understand that if at any time the school administration determines, in its sole discretion, that my actions and/or words do not support the school ministry because the parents and school are moving in different directions, or reflect a lack of cooperation and commitment to the home and CCS working together, then CCS reserves the right to request the withdrawal of my child(ren) after discussing the partnership breakdown with me.
14. I give my permission for my child(ren) to be photographed or videotaped in the course of school activities. I give consent for the school to use those pictures in promotional or advertising materials for the school, which includes the school website.
